Best Public Golf Membership in the Upstate for Two Courses

- Corporate Membership

River Falls Plantation and Village Greens Golf Club are pleased to announce their Corporate/Business membership program. The Business must purchase at least (2) Two Membership Cards (\$1,200 PER CARD) which will cover Green Fees at both River Falls Plantation and Village Greens Golf Club. The membership card is fully transferable, which means when the membership holder is not using the card, it may be given to anyone they choose to cover their green fees. The membership is valid for one year from the date of purchase. There are no monthly fees, no restaurant minimums, and no assessments. **Cart fees are required from all players and are due at time of play.**

- Individual Membership

The rate for each individual membership is \$1,200 and covers the green fees at both golf courses. **A cart rental fee is required for each player when riding.** Walking is permitted at the discretion of the pro shop but each player must pay a cart fee when walking. You may pay an additional \$200.00 per year, which will give you walking privileges for the term of the membership. Membership must be paid in full at time of purchase. The term of the Membership will be one year from the date of purchase. Individual memberships are not transferable.

- Family Membership

The rate for each family membership is \$1900 and covers the green fees at both golf courses. A cart rental fee is required for each player. Walking is permitted at the discretion of the pro shop. **Family golf privileges** are extended to husband, wife, and dependent children under the age of 21 who reside with the family. This option may be paid monthly at a rate of \$195 per month for 12 consecutive months and is non-transferrable.

- Swim Membership

Pool memberships are available for 2022 at River Falls Plantation. Family pool memberships are valid for one calendar year. The cost is \$450.00 for non-residents of River Falls and \$300 for residents.

- Driving Range Options

Individual Membership - \$350 for one calendar year.

Family Memberships - \$350 PLUS \$75 for each additional family member for one year.

Membership is for only one golf course. Please specify the course of your choice.
